<sup>2</sup> - **Custom partner schools** may elect to have their own instructors facilitate a course. Doing so reduces the tuition by \$100 for ½ credit and \$200 for 1 credit courses. This option is not available for dual credit courses. This discount increases to \$115 and \$230 respectively for schools that had their own instructors facilitate at least 300 enrollments in the prior calendar year. Credit recovery and partner-designed courses do not count toward the eligibility count, nor are they further discounted.

<sup>1</sup> - Credit recovery courses are specifically designed to allow a student to retake a course he/she previously failed or to improve his/her grade. These courses provide individualized learning through pre-testing to prescribe content that must be completed to recover credit. Students have up to 10 weeks to complete coursework in this program.

<sup>1</sup> - Placement tests are available for a limited number of courses. Placement tests help determine if a student has the necessary knowledge to succeed in a course before purchasing and enrolling in it. The student registration fee does apply.

<sup>2</sup> - Instructor Setup Fee is required for partner school instructors to facilitate Sevenstar courses and includes a mentor for one semester. Additional mentor services beyond the one semester are available for \$50 per instructor per semester.

**MATERIALS**

Some courses require supplemental materials. If a course requires an etextbook, the price is already included in the tuition or, in limited cases, a link to purchase the textbook is provided. The login credentials will be provided to the student within the first two weeks of enrollment. There may be additional course materials that need to be purchased (e.g., materials for science labs). You will be able to see the latest information in the course information section of each course. Please log in to your school's portal or request access to our demo account to see needed materials and allow time to obtain them.

**REFUND POLICY**

A student may be withdrawn from a course at any time. Transferring to another course title or switching from honors to the on-level version of a course is considered a withdrawal and is subject to the following withdrawal refund schedule:

<sup>1</sup> - These are calendar days and not business/school days. The start date is the originally requested start date, generally a Monday.

<sup>2</sup> - Refunds are not applicable for dual credit; nor student registration, application, or placement test fees. There are no refunds for a second semester of a course on Day 25+ from course start date.
